Our vision for Cumberland Care

Cumberland Care aims to ensure our services provide sustainable, high-quality care and support for the people of Cumberland. The Council will ensure that services are the right size and shape to meet the demands of our residents now and in the future.

We want residents to be able to access the support they need for themselves and their families, by providing services which maximise independence and provide more specialist and complex care. We will ensure all our residents are treated with dignity and respect.

We want every Cumberland resident to live better, healthier, and more independent lives.



Our proposals for Cumberland Care

- We want Cumberland Care homes to be good places to live, work and visit.
- We want to be able to provide the support people need now, and in the future, including increased provision of dementia care.
- Modern aids can help the effectiveness and safety of care for staff and for residents.
- The building design at Moot Lodge means it is not possible to achieve these aims.
- On 13 February 2024 the council's Executive agreed to launch a public consultation regarding the potential closure of Moot Lodge.



How does this affect staff, residents and visitors

- The building design at Moot Lodge limits what we can do to provide care in line with modern standards.
- Mechanical aids such as ceiling hoists cannot be installed, leading to additional staffing required in the home.
- Moot Lodge has limited safe outside space, making it difficult to offer regular access
 to fresh air and exercise and a quiet outdoor space away from others (particularly
 significant when caring for those with dementia).
- It is unlikely that we can adapt the building to achieve these aims.
- If the closure of Moot Lodge is approved, staff will be offered alternative
 employment in nearby services, and we will work with residents and their families to
 find good alternative care and support that meets their needs and wishes.



Moot Lodge

- Built in the 1960s, Moot Lodge can accommodate up to 18 people (currently home to 14 residents)
- Communal areas are modest and split over multiple levels, resulting in regular intervention for those who need manual assistance to move between floors.







- Parking and outside space is limited, with steps to the building a challenge for those with physical disabilities
- The bedrooms lack ensuite facilities



Alternative provision

- Eskdale House, Longtown recently refurbished to provide dementia care.
- Burnrigg Court, Carlisle purpose built in 2019.
- Independent provision in Brampton such as Greenlane House and Howard Court.



 The council will work with residents to ensure they are placed in appropriate alternative provision to meet their care needs and their personal preferences.







Consultation process

- A formal public consultation was launched on 26 February 2024. It is due to run until 23 May 2024.
- The council wishes to seek feedback from residents, their families and the public.
- Care assessments will be undertaken to understand the needs of each resident and their preferences.
- Independent advocacy is being provided to the residents by People First.
- Healthwatch Cumberland are providing independent support to assist the community to respond to the consultation.
- Once the consultation is closed the responses will be analysed and a recommendation will be made to the Executive for decision (likely July 2024).
- If the decision is taken to close Moot Lodge, a formal staff consultation will follow.

Recommendation considered by Executive	July 2024 (Executive meeting dates to be confirmed)
Formal staff consultation*	30 days
Residents are relocated and staff redeployed*	From September 2024 onwards
