

## Part 2 – Section 3: Responsibility for Local Choice Functions

### 1 ALLOCATION OF LOCAL CHOICE FUNCTIONS

- 1.1 Schedule 2 of the Local Authorities (Functions and Responsibilities) (England) Regulations 2000 (“the 2000 Regulations”) makes provision for certain functions, known as “local choice functions ” to be either executive or non-executive functions. The Council has determined that the responsibilities shall be allocated as follows:

3	The determination of any appeal against any decision made by or on behalf of the Council	Standards and Governance Committee or Staffing Committee (in respect of matters relating to disciplinary and employment)	
4	The appointment of review boards under regulations under subsection (4) of section 34 (determination of claims and reviews) of the Social Security Act 1998.	Council
