## 59. LGR Programme Update

## Subject:

The LGR Programme Manager submitted an update on the Programme in place to support Local Government Reorganisation in Cumbria. The report consisted of the latest Programme Dashboard presented to the Programme Board and a summary of the Day One Board report presented to the Day One Programme Board on 18 October 2022.

## **Reasons for Decisions**

To comply with The Cumbria (Structural Changes) Order 2022 to deliver a sustainable Unitary Council, and a sustainable Fire and Rescue Service, in an economic, efficient, effective, safe, legal and seamless fashion, delivering both benefits from Vesting Day and the foundation for further transformation in the future.

#### 60. Rural England Prosperity Fund

#### Subject:

The Corporate Director of Economic Development (Carlisle City Council) reported that government had allocated £2.52m to the three authorities which would form Cumberland from the Rural England Prosperity Fund (REPF) - Allerdale £1.3m; Carlisle £0.47m; Copeland £0.75m.

The fund would run for two years over the period 2023/24 – 2024/25 and therefore, would be managed and delivered by Cumberland Council. To draw the funding down, the District Councils must submit an addendum to the UKSPF Investment Plan that had been submitted to the Government, setting out how they intended to use funding to support rural businesses and communities. The paper sought approval from the Shadow Executive to delegate to the Interim Head of Paid Service in consultation with the Shared Prosperity Fund Senior Responsible Officer for Cumberland, the Leader of Cumberland Council, the Interim Monitoring Officer, and the Interim Section 151 Officer the authority to provide consent from the Council to any addendums to

the UKSPF Investment Plans proposed to be submitted by the District Councils.

The Corporate Director responded to questions on the linkages between the Rural England Prosperity Fund and the UKSPF.

The Leader moved the recommendations which the Governance and Enabling Portfolio Holder seconded.

#### DECISION
